

2008 Virginia General Assembly
Legislative Report

If the early signs I am seeing prove to be correct, transportation funding is headed for another trainwreck at the 08 session. This is largely based on the Governor's revised estimates for coming revenue which will be publicly presented to the legislature in mid-February. But the leaks portend bad news.

Senior transportation officials are now indicating that there is going to be a need to make about \$400 million worth of transportation funding cuts in the current proposed 2008-2010 proposed budget, based on shrinking revenues from the normal transportation sources and the doing away with the now hated abusive driver fees. But the much more serious news is that revenue forecasts for the current six-year plan suggest a billion dollar shortfall - a number equal to one full year of construction under the plan! And no one from the Governor on down, is really focusing on addressing this gigantic shortfall in the state's transportation funding budget. With no legislative solutions on the horizon, the forecast is really dim for state funded highway work over the next six years.

The broad issue of illegal immigration continues to create challenges for many lobbyists representing construction, farm and commercial businesses as conservative legislators continue to push a large number of bills that could literally close down a business for hiring an illegal alien. These various bills, like HB 90, have not yet ripened, but will start to crystallize shortly. VUHCC is trying to keep a close eye on them, if and when they do.

VUHCC has been successful in killing a number of bad truck bills, (HB 292, HB 1546, SB 558) which would allow counties across the Commonwealth to weigh trucks, collect fines, and use the proceeds for non-transportation purposes. There are still a few more of these bills floating around, and we will try and ensure they receive the same outcome.

SB 189 was also heard last week. It is legislation that we would normally oppose because it substantially raised the dollar limits of work that both counties and the state can perform with their own forces. But

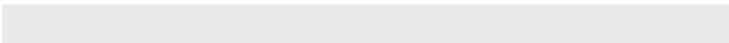
we were handcuffed by three issues that kept us from opposing the bill. First, the bill is primarily supported by the Northern Virginia Transportation Authority - an entity that we have worked hand-in-hand with for many years. Second, the current dollar caps have not been raised since 1986, and third, the language that VUHCC had placed in the law two years ago precluding a locality from doing the work if they receive at least two responsive bids from the private sector will remain in the law. Given those facts, we let this bill move forward unopposed by the VUHCC.

We are also looking at HB 1027 which would not allow commercial vehicles to be parked in some residential areas, including a pickup truck with the name of a company written on its doors. Where do some of these bills come from?

We are now approaching the final two weeks of consideration of House or Senate bills by their own bodies. This is the time that the contentious legislation will really start to surface for consideration by the various committees, including what if anything is to be done to make up for the lost revenues of the now all but gone abusive driver fees. VUHCC continues to argue that Virginia cannot simply allow the fees to not be replaced with other, and with hopefully more reliable sources of revenue.

So the next two weeks will be very interesting.
