### **HCCA-PAC**

#### What is HCCA-PAC?

HCCA-PAC was formed in 2001 to actively support and represent the Heavy Construction Contractor Association member's interest at the municipal and state level on issues.

### Why is the HCCA-PAC needed?

Every year the Virginia General Assembly, a wide variety of state regulators and local municipalities consider a number of legislative and regulatory issues that impact the vitality of the heavy construction industry. As examples, legislative and regulatory issues range from efforts to increase transportation funding, regulation on overweight trucks, requirements on safety certifications, lien and bond requirements to local land use plans are under consideration

Consequently we need to fund attendance at appropriate political events, a lobbying effort with the General Assembly and financial support to candidates where appropriate to provide a community voice for the interest of the Heavy Construction Contractors Association members.

#### **How Does the HCCA-PAC operate?**

The funding for the HCCA-PAC comes from two primary sources-fund raising events and activities of the HCCA-PAC and voluntary contributions from the membership. These contributions are above and beyond the membership dues to the organization. They are maintained in a separate account and contributions and all expenditures are reported to the Virginia State Board of Elections. The greater level of support enables the HCCA-PAC to increase its activities in support of common goals of the membership.

### Can my business or company make contributions to the HCCA-PAC?

Yes! Virginia law allows both individuals and business corporations to contribute to the candidates and Political Action Committees such as HCCA-PAC.

### Who receives Contributions from the HCCA-PAC?

The HCCA-PAC is governed by a committee of four Trustees appointed by the HCCA-Board of Directors. These four trustees review opportunities to make contributions on behalf of the HCCA-PAC. When determining which candidates to support the PAC Trustees consider their understanding and support of our industry, and their support of a sound business climate for Virginia. The Trustees will make a similar analysis when working with our lobbyist considering activities to support and attend on behalf of HCCA-PAC.

### Is the HCCA-PAC bipartisan?

Yes! HCCA-PAC is completely independent and bipartisan. All candidates are judged strictly on their positions as related to our industry and business related issues.

## I support my own candidates... Why should I give to HCCA-PAC?

HCCA-PAC encourages members to contribute to local candidates: however HCCA-PAC provides a unified community voice to express the opinion of the industry. In addition the PAC works with related utility and heavy construction groups to form a statewide coalition. When we give collectively and express our opinions collectively we have a much stronger voice.
